Prior to the initial public offering of EHT (the "Offering"), Fortress Empire Group Ltd held 1 Stapled Security which was issued upon the constitution of Eagle Hospitality Real Estate Investment Trust ("EH-REIT") and Eagle Hospitality Business Trust ("EH-BT") on 11 April 2019.

As stated in the prospectus of EHT dated 16 May 2019 (the "Prospectus"), concurrently with, but separate from the Offering, the vendors of the USHI Portfolio (as defined in the Prospectus) and the ASAP6 Portfolio (as defined in the Prospectus), will receive 142,459,998 Stapled Securities in satisfaction of the purchase consideration for the USHI Portfolio and the ASAP6 Portfolio (the "Consideration Stapled Securities") and will direct (i) 37,500,000 Consideration Stapled Securities to be issued to Fortress Empire Group Ltd; (ii) 1,886,000 Consideration Stapled Securities to be issued to Vertical Gain Investments Inc; and (iii) 26,715,999 Consideration Stapled Securities to be issued to Dragonbay Fortune Inc (collectively, the "Relevant Transactions").

As a result of the Relevant Transactions, Fortress Empire Group Ltd, Vertical Gain Investments Inc and Dragonbay Fortune Inc collectively have a direct interest in an aggregate of 66,102,000 Stapled Securities.

Each of Fortress Empire Group Ltd, Vertical Gain Investments Inc and Dragonbay Fortune Inc are wholly-owned by Mr Howard Chorng Jeng Wu. Accordingly, Mr Howard Chorng Jeng Wu has a deemed interest in the Stapled Securities held by Fortress Empire Group Ltd, Vertical Gain Investments Inc and Dragonbay Fortune Inc.

Pursuant to a stapled security lending agreement dated 16 May 2019 between DBS Bank Ltd. (the stabilising manager for the Offering) and Fortress Empire Group Ltd, DBS Bank Ltd. has borrowed 37,500,000 Stapled Securities ("Loaned Stapled Securities") from Fortress Empire Group Ltd. As a result of this transaction, Fortress Empire Group Ltd. has a deemed interest in the Loaned Stapled Securities. Mr Howard Chorng Jeng Wu continues to have a deemed interest in the Loaned Stapled Securities as well.

EH-REIT is managed by Eagle Hospitality REIT Management Pte. Ltd. while EH-BT is managed by Eagle Hospitality Business Trust Management Pte. Ltd.
