As stated in the prospectus of EHT dated 16 May 2019 (the "Prospectus"), concurrently with, but separate from the Offering, the vendors of the USHI Portfolio (as defined in the Prospectus) and the ASAP6 Portfolio (as defined in the Prospectus), will receive 142,459,998 Stapled Securities in satisfaction of the purchase consideration for the USHI Portfolio and the ASAP6 Portfolio (the "Consideration Stapled Securities") and will direct 10,256,000 Stapled Securities to be issued to Empress Star Ventures Inc (the "Relevant Transaction") as part of the remuneration package of Mr Salvatore Takoushian as Chief Executive Officer and President of Eagle Hospitality REIT Management Pte. Ltd. (as manager of Eagle Hospitality Real Estate Investment Trust ("EH-REIT")) and Eagle Hospitality Business Trust Management Pte. Ltd. (as trustee-manager of Eagle Hospitality Business Trust ("EH-BT")).

As a result of the Relevant Transaction, Empress Star Ventures Inc has a direct interest in an aggregate of 10,256,000 Stapled Securities. Empress Star Ventures Inc is wholly-owned by Mr Salvatore Takoushian. Accordingly, Mr Salvatore Takoushian has a deemed interest in the Stapled Securities held by Empress Star Ventures Inc.
