Eagle Hospitality REIT Management Pte. Ltd. (the "REIT Manager") received 2,170,797 Stapled Securities in EHT at US\$0.6617 per Stapled Security as 100.0% of the Base Fee component of its management fees for the period from 1 July 2019 to 30 September 2019 ("Financial Period")

The issue price per Stapled Security is the volume weighted average traded price for a Stapled Security for all trades done on the Singapore Exchange Securities Trading Limited in the ordinary course of trading for the last ten business days immediately preceding 30 September 2019, being the end date of the Financial Period.

The Listed Issuer, EHT is a stapled group comprising Eagle Hospitality Real Estate Investment Trust ("EH-REIT") and Eagle Hospitality Business Trust ("EH-BT"). Each stapled security comprises one unit in EH-REIT stapled to one unit in EH-BT. EH-REIT is managed by the REIT Manager while EH-BT is managed by Eagle Hospitality Business Trust Management Pte. Ltd.
